- **A1. Call to Order by Chair** C. Karlson called the meeting of the Board of Selectmen to order at 8:01 a.m. in the Selectmen's Meeting Room in the Wayland Town Building when a quorum was present, noted that the meeting was not being broadcast or videotaped for later broadcast by WayCAM, and reviewed the agenda for the public.
- **A2.** Announcements and Public Comment The Wayland Concert Series will present a concert at Wayland High School at 8:00 p.m. on Friday, November 15. The concert is free and open to the public. There was no public comment.
- **A3.** Town Manager Special Act: Working session to review and discuss latest draft, develop FAQs, discuss community presentation and next steps L. Anderson reported that Town Counsel would be available by phone if needed. She walked the Board through the edits made by Town Counsel based on discussion at the Nov. 4 BoS meeting. The Board noted some additional minor edits and discussed the need to understand how best to protect Chapter 347 of the Acts of 2008 (Establishment of a Department of Public Works) relative to the Town Manager Special Act.

At 8:19 a.m. C. Karlson phoned Town Counsel, Carolyn Murray. C. Murray, and the Board discussed the minor revisions and agreed on wording regarding Chapter 347 with her. C. Murray agreed to make the additional revisions and return an updated draft for posting on the Town's website in preparation for the Community Forum. The call ended at 8:40 a.m.

The Board discussed the need to inform citizens of the upcoming forum and to revise the presentation based on the new draft of the Special Act. There was consensus authorizing L. Anderson to write a letter to the editor on behalf of the Board with details of the forum to be held on Thursday, November 21 at 7:00 p.m. in the Town Building. The Board also authorized C. Karlson to revise the PowerPoint presentation as discussed. The Board deferred working on the Frequently Asked Questions until after the forum.

L. Miller and E. Doucette entered the meeting at 8:45 a.m.
