# **Public Buildings Director Updates**

B. Keefe reports the Middle School resiliency project closeout is about complete. Green Community grant progress is as follows: van with regenerative braking is ordered; Pat Morris will register for the Building Operator Certification training; middle school lighting project is nearly complete; and high school retro commissioning being scheduled. Heat pumps with gas backup will be installed at the Loker School during the roof replacement.

# Regional Energy Planning Assistance (REPA) Grant

Sasha Shyduroff of the Metropolitan Area Planning Council presented her thorough study of the town's buildings energy use (especially Middle School, Claypit Hill, DPW, Town Building, Public Safety) using the

Green Communities Energy Analysis Tool, which was helpful in measuring performance and identifying issues for more study, including examining practices, new energy audits or retro-commissioning.

## **Eversource Rate Case**

J. Harper reported Natick has approached Wayland and other towns to express concern over Eversource's proposed rate increase affecting municipal solar developments.
