S. Rufo called the meeting to order at 7:36pm.

Review of minutes from December 11, 2017 and January 2nd 2018

- S. Glovsky moved to approve the minutes of December 11th as amended. Z. Ventress seconded. All in favor

Update of Director of Assessing Position

- S. Rufo stated the HR board had moved their meeting up to Monday the 22nd rather than the 29th, and had approved the hiring of Bruce Morgan as the new Assessing Director at a comparable level and rate as the previous Director, in recognition of his experience. The new director, will start February 12th.
- B. Morgan had contacted Chair S. Rufo and stated he would like to come into the office one day soon to review upcoming and ongoing issues to be immediately addressed.

Update of Real Estate Abatement Applications

J. Marchant reported the number of abatement applications (15) the office had received thus far. She also updated the board that the personal property contractor RRC started their annual Wayland inspections today. Since this is a certification year, they will be visiting every business in Wayland over the course of this week to list the personal property. Those in the field have identification and the Wayland Police Department has been notified of this activity.

Correspondence

- 46 Cedar Crest- has filed for findings of fact to the ATB as a result of the ATB's decision in favor of the town
- 59 Old Sudbury Road- letter stating the house is vacant and soon-to-be demolished
- 533 Boston Post Road- letter received from their attorney requesting an extension from BoA and the ATB related to their appeal case until mid-February. BoA was agreeable.

The board signed their approval of the motor vehicle warrants and commitments.

Statutory Exemptions

The board reviewed all of the applications for exemptions. They had several questions about individual applications and decided to defer any approvals until those questions can be addressed.

Circuit Breaker Applications

There was a question about the signing procedure for Circuit Breakers by S. Glovsky. The board deferred this topic until the new Director could be part of this discussion.

S. Rufo updated the board that the office received a question regarding the assessment for the property, which was addressed by staff.

Board Member Requested Discussion Topics

Memo from Carolyn M Murray dated 12/9/2017, Open Meeting Law: Minutes

S. Glovsky wrote up a review of his interpretation to the Attorney General and Ms. Murray's positions on the open meeting law and raised several questions and opposing procedures, which he presented. Steve stated the board should confirm what their priority is; and also what the law says they should do. Exemption applications state they are not open to public inspection. If/when docs are brought to open meetings, does that open them to public inspection? He doesn't think it should, but the Attorney General's office and Town Counsel interpret it differently.

The board continued this discussion on open meeting law. They agreed to reread all of the information and think about how to move forward at a future meeting.

S. Glovsky agrees no public should be able to see applications, but if a board member was not part of the review process, they should not sign it. Applications should be at the meetings so they can be reviewed or double-checked.

Chairman Authority

S. Rufo distributed a 2005 document that outlines the duties of the Chair and gave a copy to S. Glovsky for review.

Request for Town Counsel Services

S. Rufo suggested deferring until the new director starts to further discuss this issue.

Topics not reasonably anticipated by the Chair 48 hours in advance of Meeting, if any

S. Rufo said there was a request from the FinCom to Acting Assessing Director Don Clarke, asking for a spreadsheet to extract assessment data. S. Rufo suggested waiting for the new director to reply to understand the data the FinCom was requesting and the purpose for which the information would be used and if there was a more informative way to share the data.

The FinCom Chair D. Watkins had sent a follow-up email to S. Rufo on Sunday that he needed the information for a debt exclusion presentation FinCom was making to the BOS the next day. She did not receive the information in time to respond to him.

Thoughts and Concerns from BOA members

S. Glovsky suggested the board deem deny any application that is not based on specific data. S. Rufo suggested he wait to go through the full abatement process before suggesting the board makes any policy changes.

Public Comment

None- no public in attendance.

Upon the issuance of the varrant to distrain or commit, you or your designee shall proceed to enforce the collection of said excise in accordance with the provisions of said court varrant.
