Attendees: J. Brodie, Z. Ventress, M. Upton, S. Glovsky, J. Todd, and Director of Assessing B. Morgan

Meeting called to order

J. Brodie called the meeting to order at 7:50 pm

Review of the minutes from May 6, 2019

The Board reviewed the minutes.

Z. Ventress moved to approve the minutes of May 6, 2019. M. Upton seconded. Vote: Four in favor with S. Glovsky abstaining due to not being present at that meeting.

Director Morgan's Review and Update of office activity:

- B. Morgan stated the location listed on the agenda will state Town Building for the future.
- J. Brodie said the Board's last executive session was recorded by mistake. It has since been deleted. Also the person who books the room wasn't aware there was an executive session so the room for the last meeting wasn't equipped for privacy.

Update on pending ATB cases

The nursing home on Commonwealth Road filed as expected. It's their first year filing. B. Morgan said he met the owner and had a tour at the end of the abatement period. He stated that 42 Shaw Drive filed again even though there was an abatement granted in FY'19.

DLS Law opinion of role of BOA Clerk/Secretary

- B. Morgan said DLS Law suggested looking up the definitions of the position Clerk/Secretary and making a decision if it's needed. They had no awareness of a town who had a clerk and or secretary and didn't know of a system that tracks such information. B. Morgan said it seems like the law has fallen out of favor.
- B. Morgan stated the board needs to decide who will take executive session minutes. B. Morgan said the temporary employee's hours increased from 20-24 hours a week.

There's a potential possibility to add more hours, maybe shared. M. Upton requested a record of accounting of how many sales there were in a certain period and how many inspections have been completed for 2018 and year to date for 2019. She also request information on cyclicals.

Correspondence and Documents for BOA Review and Signature:
Warrants and Commitments for FY2020 First and Second Quarter Real Estate,
CPA, and Personal Property Tax. The Warrant and Commitments for FY2020

First and Second Quarter Real Estate, CPA, and Personal Property Tax were presented to the board for signatures. Four members signed with S. Glovsky abstaining.

J. Brodie was looking at old minutes and reminded the Board that the signing of warrants was suggested to be a fixed agenda item and asked why it hasn't been done. S. Glovsky reminded the Board that doing that is a violation of the Open Meeting Laws.

J. Brodie stated that B. Morgan will be out of the office for three days. B. Morgan said M. Lanefski is the point person in the office but he will be checking email and be accessible. J. Brodie said he is available as well if he has any questions. September 30, 2019 is the deadline for the Town Report. B. Morgan agreed to have a draft ready for the Board to review at the meeting date following August 15, 2019.

Topics not reasonably anticipated by the Chair 48 hours in advance of meeting, if any

Thursday afternoon J. Brodie had a meeting with Town Administrator L. Miller, BoS Chair C. Karlson and BoS member L. Anderson. J. Brodie discussed some of the items that were covered. It was agreed that all communication channels need to be improved. The job description for the office assistant has been approved by the union and posted internally. He said he was assured that the BOA's approved budget would not be second guessed. He stated that training money in the budget will not be approved unless clearly argued it will benefit the town. J. Brodie said he's concerned about the effects of conducting the affairs of the office using contractors and temporary workers and discussed it at the meeting. He requested access to the legal costs resulting from BOA's actions and requests be made available to the Board. He said there were no objections. The statutory responsibilities and the enormous potential for conflicts of interest were also discussed. He said there are other issues still in discussion and will be for further review. One of them is the issue of B. Morgan's supervision.

Thoughts and Concerns from BOA members

M. Upton asked if there will be a change in meeting times. Z. Ventress said in the summer he can meet earlier but that may change in the fall. J. Brodie proposed starting the meetings at 7:15pm again. Z. Ventress requested info regarding the audit or any adjustments and/or resolutions. J. Todd asked if there has been any communication at all between departments, specifically with the Treasurer/Collector. B. Morgan said there has not been a lot. S. Glovsky said the BOA never received the outstanding Warrants from the previous Collector. J. Brodie asked B. Morgan to discuss the Warrant and audit issue with the Treasurer/Collector and Town Administrator. S. Glovsky said he looked at minutes from the Town of Concord and how they handle the abatement process. He said it's all public in Concord and he thinks Wayland should handle it the same way. He suggested members look at minutes from Concord.
