### **DPW Director's Report**

#### September 12, 2017

#### **Engineering Division**

- Reviewed Happy Hollow Access Road and Water Main project; provided comments; attended pre-bid meeting; assisting in the project implementation.
- Assisting Conservation Commission in the development of a parking plan for Mainstone Trail Access.
- Assisting Recreation Department in the bidding and contracting of the Town Building Field Refurbishment and Oxbow Field Projects.
- Assisting in the oversight of Town wastewater treatment facilities O&M Contractor.
- Coordinating with GIS to develop and publish GIS layers for the water, wastewater and storm drain system.
- Assisting in the development of an emergency water Inter-municipal agreement with Sudbury Water District.
- Coordination with MassDOT for Route 20 resurfacing.
- Reviewed and commented on Planning Board subdivisions and 40B applications; 24 School Street, Cascade
- Coordination of Rivers Edge due diligence activities.

#### **Water Division**

#### **Treatment:**

- Rebuilt and replaced 3 leaking bray valves on filter skids
- Rebuilt and calibrated all 3 of the plants ozone concentration IN USA analyzers
- Rebuilt and calibrated all 6 of the plants ozone and oxygen ambient sensors
- Installed new chlorine day tanks, new chemical lines, valves, backpressure valves, and gauges at both Chamberlain and Campbell chlorine system.

#### Distribution:

- Repaired 4 Water Main Breaks:
  - o 26 Sedgemeadow
  - o 48 Sedgemeadow
  - o Alpine Road at Field
  - 35 White Road
- Removed 12" system check valve located at the intersection of Cochituate Road and School Street. Check valve was a part of the original system installed in the early 1940's. The check valve is no longer needed and posed a significant flow restriction.
- Crews replaced a main to curb water service at 8 Glover Road. The leak was discovered during our Annual Water System Leak Detection.
- Crews inspected 3 Homeowner leak repairs:
  - o 6 Astra
  - o 338 Old Conn. Path
  - o 59 Clubhouse Lane
- Crews replaced an out of service Fire Hydrant at 73 Plain Road

#### **Highway & Park Division**

- **Roadway Paving Update:** Waltham Rd, Kelly Lane, Alpine Rd, Apple Tree Lane, Williams Rd, Bow Rd, and a Portion of Lincoln Rd, Have been reclaimed, graded and binder coat installed Currently re-setting and adjusting structures.
- Parkland Traffic Island: Installation, signage, and center complete. Awaiting pavement markings.
- Rt 27/30 Intersection: According to the State DOT project engineer there is a delay stemming from coordination of utility companies, regarding, movement of all public and private utilities from the current poles.
- Athletic Fields: Fall field maintenance underway, Slice Seeding, Aeration and fertilization of all athletic fields
- **Tree Warden:** The DPW has hired a contractual licensed arborist to work in conjunction with the DPW and Town as an official Tree Warden.
- **Touch-a-Truck**: Preparation has begun to again assist the Recreation department with the 12th annual Touch a truck event Scheduled for September 23, 2017.

#### **Transfer Station Division**

- As of 8/29/17, 1716 Full Stickers have been sold. Of those, 944 were paid by check (55%), 708 were paid by credit card on-site (41%), and 64 were purchased online (4%). In FY17, 1691 stickers were sold as of 8/29/16.
- As of 8/29/17, 143 Recycle-Only Stickers have been sold. Of those, 99 were paid by check (69%) and 44 were paid by credit card on-site (31%). In FY17, 150 stickers were sold as of 8/29/2016.

Baston reviewed the agenda.

Baston asked for public comment – there was none.

# <u>Discussion and Potential Board Vote on Fall Town Meeting Article to Fund the Demolition of the Structure at 107 Old Sudbury Road</u>

Baston noted the original article to purchase the property did not include funding for the demolition.

Wegerbauer asked if there is grant money available.

Holder noted that any available grants exclude the costs of demolition alone.

Lowery asked Holder to confirm that there are no surplus funds left over from the purchase of the property.

Lowery made a motion that the article be brought forward for Fall Town Meeting based on the cost estimate provided.

Mishara 2<sup>nd</sup>, all in favor.

Wegerbauer discussed potential sources of funding for the article, noting that he is against the use of retained earnings for capital projects.

Baston noted that the Board of Public Works' Finance Committee contacts would like to be included in future meetings where budgetary issues are discussed.

Baston asked if the amount of water pumped this year has decreased due to the increased rainfall.

Baston asked about the status of the triangular lay-down area.

Holder responded that material is currently being removed from the area.

Baston asked about the status of the Happy Hollow access road.

Holder responded that he anticipates construction to begin by November 1.

Baston asked about updates to the status of private roads.

Holder responded that he is awaiting legal opinion on the definition of a road 'open for public use.'
