Meeting Minutes BOARD OF SELECTMEN Monday, March 16, 2020 6:00 p.m. Wayland Town Building Council on Aging Room 41 Cochituate Road, Wayland, MA

Note: In compliance with the March 12, 2020 Massachusetts Office of the Governors' Order Suspending Certain Provisions of the Open Meeting Law M.G.L. Chapter 30A, Section 20, the March 16, 2020 Board of Selectmen meeting was livestreamed on local broadcast on WayCAM. Public Comment was received by telephone during the time designated for Public Comment.

- **A1. Call to Order by Chair, Review the Agenda for the Public** C. Karlson called the meeting of the Board of Selectmen to order at 6:11 p.m. in the Wayland Town Building Council on Aging Room when a quorum was present, and noted that the meeting would be broadcast live and recorded for later broadcast by WayCAM. C. Karlson announced a phone number for residents to call to offer public comment during the Public Comment agenda item. C. Karlson reviewed the agenda and the revised agenda for the public.
- **A2.** Announcements and Public Comment (included in item 3) C. Karlson announced that she would recuse herself from the discussion of agenda item A3 on the Town Election due to her candidacy for Board of Selectmen in the same election and that D. Levine would chair that portion of the meeting in her absence. D. Levine read a statement dated March 16, 2020 to express the Board's appreciation for staff, committee/board volunteers, Wayland citizens, businesses, organizations, faith communities, and the entire Wayland community for their response to the COVID-19 emergency.
- A3. Coronavirus: Town Administrator Update and Review of Response Plan L. Miller updated the Board on developments at the state level. Massachusetts Governor Charlie Baker made several orders on March 15, suspending certain provisions of Open Meeting Law (OML), prohibiting gatherings of 25 people or more, and prohibiting on-site consumption in restaurants, and food and beverage establishments. L. Miller reported that the Town Building was closed to the public except by appointment for essential business. Also, the Town closed the public library, fields, playgrounds, and recreation areas due to increased congregation in those spaces after the closure of schools. L. Miller reminded the public that large gatherings are discouraged. The Town reduced personnel to only essential personnel. Meals will continue to be provided to students and seniors. L. Miller announced the Wayland Health Department Coronavirus Hotline (508-358-6805) for medical questions, and a general help line (508-358-7701) for residents who may need assistance obtaining basic and important life necessities, such as food or medications. 1. Discussion on the following topics

Local State Of Emergency

L. Miller noted the Town is operating under a federal and statewide order for state of emergency. There are some advantages to declaration of local state of emergency and that doing so would allow the Town more authority: for example the authority to close public spaces like the playgrounds. D. Levine and T. Fay noted that Wayland bylaw Chapter 58 Section 3 terminates a declaration of local emergency five days from the day it takes effect, and would require the Board to convene every five days to re-declare.

At 6:45 p.m. C. Karlson recused herself from the discussion on Town Elections and left the room, D. Levine chaired the next portion of the meeting.

Postponing Town Election

L. Miller expressed doubt that the Town Election scheduled for March 31 would be possible given the public health emergency. The Secretary of State does not give authority to the Town to postpone Town Elections. L. Miller discussed two ways to postpone the Town Election. The Town could file an emergency motion and court order to postpone to a date certain, or request the Governor to file a bill with the legislature to an outside date. L. Anderson reported that Wellesley and Lincoln had postponed the Town Election through the courts. D. Levine suggested pursuing both options to postpone the election by whichever authority the Town could, as it would not be possible to hold the election on Mar. 31. L. Anderson stated support for declaring a local state of emergency to allow the Town to pursue postponement of the election.

L. Anderson suggested a draft motion, that the Board of Selectmen vote to authorize the Town Administrator to pursue multiple avenues to postpone the Town Election, including a court order, legislative act or Governor's Bill to decouple the Town Election and Annual Town Meeting; and to authorize the Town Administrator to pursue the postponement of the Town Election to a date no later than Oct. 13, 2020; and to authorize the Town Administrator and Town Clerk to work on logistical details of the postponement. In discussion, L. Anderson stated that the intent of the Board was to adhere to the Town Code Chapter 36 Section 1 requiring the election take place within seven days, but no fewer than two days, before the Annual Town Meeting, if possible. T. Fay and D. Levine concurred and expressed the need for flexibility. The Board heard Public Comment.

2. Open for Public Comment *by telephone

A. Lewis, Claypit Hill Road, commented by telephone and recommended that the Board select a date certain for the Town Election, and extend that date as necessary. A. Lewis felt Oct. 13 was too late. A. Lewis voiced her opinion that the Town Election was part of Town Meeting, and in an emergency it was not important to go to the legislature. As an election worker she would not feel comfortable working at an election.

- G. Schuler, Old Connecticut Path, commented by telephone and stated disagreement with decoupling the Town Election from the Town Meeting, as it was not in line with the intent of the bylaw.
- D. Berry, George Street, was present at the meeting and speaking as Town Moderator, also disclosed he was up for re-election. D. Berry stated agreement with A. Lewis and G. Schuler, and referenced M.G.L. Chapter 39 Section 9A that requires such election and vote shall be deemed parts of the annual town meeting.
- C. Karlson rejoined the meeting at 7:13 p.m. D. Levine updated C. Karlson on the draft motion before the Board.

Postponing Town Meeting

- S. Koffman, Sherman's Bridge Road, commented by telephone that she served as a warden for the election. She expressed concern with the argument regarding disenfranchisement of voters, that there would be many people at the election polls including personnel, police, wardens, workers, in addition to voters. She noted that current elected public officials terms continue until the adjournment of Town Meeting.
- G. Harris, Holiday Road, commented by telephone and stated agreement with other public comments, declaration of a local emergency, and postponement of the Town Election and Annual Town Meeting.
- C. Lewis, Claypit Hill Road, commented by telephone and suggested a simple solution of postponing the meeting, and waiting for the Moderator, who had the authority, to call the meeting when possible.
- L. Miller noted M.G.L. Chapter 39 Section 10A authorizes the Moderator to postpone for thirty days not to exceed June 30 in a public safety emergency, but there was a proposal state-wide to add language to include a public health emergency. D. Berry stated that he was not aware of any authority for the Moderator to call Town Meeting at any time.

Local State of Emergency

C. Karlson moved, seconded by L. Anderson, that the Board of Selectmen declare a state of emergency under Chapter 58 Section 3 of the Town Code. YEA: L. Anderson, M. Antes, T. Fay, C. Karlson, D. Levine. NAY: none. ABSENT: none. ABSTAIN: none. Adopted 5-0.

Postponing Town Election

L. Anderson moved, seconded by T. Fay, that the Board of Selectmen vote to authorize the Town Administrator to pursue multiple avenues to postpone the Town Election, including a court order, legislative act or Governor's Bill to decouple the Town Election and Annual Town Meeting; and to authorize the Town Administrator to pursue the postponement of the Town Election to a date no later than Oct. 13, 2020; and to authorize the Town Administrator and Town Clerk to work on logistical details of the postponement. YEA: L. Anderson, M. Antes, T. Fay, D. Levine. NAY: none. ABSENT: none. ABSTAIN: C. Karlson. Adopted 4-0-1. C. Karlson abstained due to her candidacy for Board of Selectmen in the election.

T. Fay moved, seconded by M. Antes, that the Board of Selectmen re-vote the previous motion to authorize the Town Administrator to pursue multiple avenues to postpone the Town Election, including a court order, legislative act or Governor's Bill to decouple the Town Election and Annual Town Meeting; and to authorize the Town Administrator to pursue the postponement of the Town Election to a date no later than Oct. 13, 2020; and to authorize the Town Administrator and Town Clerk to work on logistical details of the postponement. YEA: L. Anderson, M. Antes, T. Fay, C. Karlson, D. Levine. NAY: none. ABSENT: none. ABSTAIN: none. Adopted 5-0.

D. Levine transferred the responsibilities of Chair back to C. Karlson at 7:54 p.m.

Postponing Town Meeting

D. Levine moved, seconded by T. Fay, that the Board of Selectmen vote to support the Town Moderator and the Board signing the document entitled "Wayland Town Moderator Notice of Intent to Declare Recess and Continuance of April 5, 2020 Annual Town Meeting"; and support the Moderator's decision to determine the date to insert in the document entitled "Wayland Town Moderator Notice of Intent to Declare Recess and Continuance of April 5, 2020 Annual Town Meeting"; and support the intent of the Town bylaw coupling the Town Election and Town Meeting within seven days. YEA: L. Anderson, M. Antes, T. Fay, C. Karlson, D. Levine. NAY: none. ABSENT: none. ABSTAIN: none. Adopted 5-0.
