If residents miss the deadline, they lose one year of tax relief. Moreover, the Assessors' website does not have the correct information. A grace period for this year is not possible.
	Tax Preparation: The COA has a full schedule of AARP tax preparers; they are using Hearing Room 3.
DISCUSSION	Programs: Duplicate Bridge will be reintroduced in the spring. Although bridge continues to be popular, there are frequent requests for the return of Texas Hold'em classes taught by a player from the World Poker tour. The Self-Care program is almost on wait list.
