BY SIGNING THIS FORM, THE APPLICANT, OWNER, AND EXCAVATOR ALL ACKNOWLEDGE AND CERTIFY THAT THEY ARE FAMILIAR WITH, OR, BEFORE COMMENCEMENT OF THE WORK, WILL BECOME FAMILIAR WITH, ALL LAWS AND REGULATIONS APPLICABLE TO WORK PROPOSED, INCLUDING OSHA REGULATIONS, G.L. c. 82A, THEY COVENANT AND AGREE THAT ALL WORK DONE UNDER THE PERMIT ISSUED FOR SUCH WORK WILL COMPLY THEREWITH IN ALL RESPECTS AND WITH THE CONDITIONS SET FORTH BELOW.

THE UNDERSIGNED OWNER AUTHORIZES THE APPLICANT TO APPLY FOR THE PERMIT AND THE EXCAVATOR TO UNDERTAKE SUCH WORK ON THE PROPERTY OF THE OWNER, AND ALSO, FOR THE DURATION OF CONSTRUCTION, AUTHORIZES PERSONS DULY APPOINTED BY THE MUNICIPALITY TO ENTER UPON THE PROPERTY TO MONITOR AND INSPECT THE WORK FOR CONFORMITY WITH THE CONDITIONS ATTACHED HERETO AND THE LAWS AND REGULATIONS GOVERNING SUCH WORK.

THE UNDERSIGNED APPLICANT, OWNER, AND EXCAVATOR AGREE JOINTLY AND SEVERALLY TO REIMBURSE THE MUNICIPALITY FOR ANY AND ALL COSTS AND EXPENSES INCURRED BY THE MUNICIPALITY IN CONNECTION WITH THIS PERMIT AND THE WORK CONDUCTED THERE-UNDER, INCLUDING BUT NOT LIMITED TO, ENFORCING THE REQUIREMENTS OF STATE LAW AND CONDITONS OF THIS PERMIT, INSPECTIONS MADE TO ASSURE COMPLIANCE THERE-WITH, AND MEASURES TAKEN BY THE MUNICIPALITY TO PROTECT THE PUBLIC WHERE THE APPLICANT, OWNER, OR EXCAVATOR HAS FAILED TO COMPLY THERE-WITH INCLUDING POLICE DETAILS AND OTHER REMEDIAL MEASURES DEEMED NECESSARY BY THE MUNICIPALITY.

THE UNDERSIGNED APPLICANT, OWNER, AND EXCAVATOR AGREE JOINTLY AND SEVERALLY TO DEFEND, INDEMNIFY, AND HOLD HARMLESS THE MUNICIPALITY AND ALL OF ITS AGENTS AND EMPLOYEES FROM ANY AND ALL LIABILITY, ABUSES OF ACTION, COSTS, AND EXPENSES RESULTING FROM OR ARISING OUT OF ANY INJURY, DEATH, LOSS, OR DAMAGE TO ANY PERSON OR PROPERTY DURING THE WORK CONDUCTED UNDER THIS PERMIT.

CHECK LIST FOR TRENCH PERMITS

For Digging on own property where hole is 3 feet or deeper and 2 feet wide for septic, pools, water lines/issues, etc.

For a trench in a public road

If trench is more than 3 feet deep, please complete a Trench permit – no fee required.

- 1. Read and review Trench Permit regulations and permit form. Must comply with all.
- 2. Complete, date and sign with all required signatures, Trench Permit.
 - A. Include Dig Safe #
 - B. Include up-dated Insurance Binder (\$1,000,000 insurance binder certificate of general liability)
 - C. Provide copies of valid hoisting licenses for heavy equipment operators
 - D. Provide check for \$25 made out to the Town of Wayland
- 3. A water mark-out must be scheduled following the acceptance of a Trench Permit. Contact the water department at 508-358-3672 to schedule.
- 4. Never Leave a Trench unattended!
- 5. Contractor/Excavator must provide protection or barrier to the Town's roadway while equipment is being operated, transported, loaded, or unloaded within the roadway or Town's right-of-way.
- 6. Contractor/Excavator will be responsible for any damage incurred to Town's infrastructure as a result of work under this permit, and the Town shall seek recourse for all cost to bring right of way back to preconstruction conditions.

NOTE: This is not intended to take the place of the Town of Wayland Trench Permit Regulations, nor the State of Massachusetts' Regulations. Permittee must fully abide by the Regulation as outlined in the Town of Wayland and State of Massachusetts' Regulations for Trench Permits. I have read the Town of Wayland Permit Regulations, fully grasp and understand these regulations, and agree to abide by all that is required.
