### **Executive Session**

DC moved to go into Executive Session pursuant to Massachusetts General Laws, Chapter 30A, Section 21(a)(3) to discuss a grievance with Wayland Fire IAFF Local 1978, and Massachusetts General Laws, Chapter 30A Section 21(a)(3) to review and consider for potential release the following Personnel Board executive session minutes: 10/11/23. ## Discussion of Possible Changes to the Chapter 43 Personnel Bylaw.

MP said she would call the Select Board chair regarding the process for proceeding with revisions to the Personnel Bylaw since it's the Select Board's article. The Personnel Board would like to let the Select Board know what it thinks is important for Chapter 43 revisions and how the Town might utilize the Personnel Board in the future. MP and DC will form a subcommittee to compile the information collected by the PB and provide input to the Select Board.

General Discussion on Executive Session Minutes and Update from Chair on Discussion with the Attorney General's Division of Open Government.

MP told the Personnel Board that she spoke to the Attorney General's office about the Personnel Board's executive session minutes questions. MP said there is not much information about when executive session minutes must be approved. MP suggested the Personnel Board review executive session within three regular meetings, not three executive session meetings. MP said that we could approve executive session minutes in open session if there is no sensitive information involved and the Personnel Board is merely releasing minutes, and the Personnel Board would not be waiving its right to call an executive session in the future should it determine it needs one to discuss the executive session minutes.
