The project set forth is proposing a new parking lot off of the high school main entrance driveway to service the proposed six tennis and two basketball courts and remove the existing parking lot associated with the current basketball courts accessed from Old Connecticut Path. New sidewalks are also proposed providing access to the new courts. Included within the project are improvements to the existing running track and turf field stadium area. The improvements include replacement of running track, turf field, grandstand bleachers with press box, softball field and support building for the stadium. The support buildings include a restroom building, ticket and concessions building and storage building.
