## Dear Planning Board Members:

On behalf of Twenty Wayland, LLC, this is to transmit to the Planning Board our Concept Plan submittal for the referenced project as required by Article 2304.2 of the Mixed Use Overlay District Zoning (MUOD Zoning) approved by the Attorney General on June 27, 2006. Given that the Planning Board does not have Rules and Regulations at this time, we are submitting one copy of this letter to the Town Clerk for record purposes.

As required in Section B4 of the executed Development Agreement we have deposited \$10,000 with the Wayland Treasurer pursuant to MGL Ch 44 Section 53G for the Concept Plan Review

We are providing twenty (20) copies of the plans listed in Table 1.

The Concept Plan submittal depicts the proposed residential and commercial uses. The commercial spaces are noted as "Retail" which could be the grocery store (for the 45,000 sf space), restaurant uses, or other uses allowed by the MUOD Zoning. We have also shown a suggested location for the municipal building.

Finally, we have reviewed the draft Rules and Regulations that are currently being contemplated by the Planning Board and we have attempted to address the following items that we expect may be in the final regulations:

- Limits of Environmental Constraint. The attached figure provides the areas that we believe Raytheon will allow residential uses to be developed.
- Locus Map. Our Cover Sheet provides a locus map depicting the general site layout and abutting property. Drawing EX-2 provides the GIS information of adjacent properties;
- Existing Conditions Plan. The existing site features, easements, utilities, wetland resource areas; and buildings are provided on the Existing Conditions Plan; and
- Wastewater Disposal Facility Information. We plan to discharge 45,000 gallons per day (gpd) into the Wayland Wastewater Management District Commission wastewater treatment plant and also develop some on-site septic systems. We have noted the primary and reserve leaching areas for the potential septic system. No reserve areas are required to be shown for the treatment plant because the facility is municipally owned.

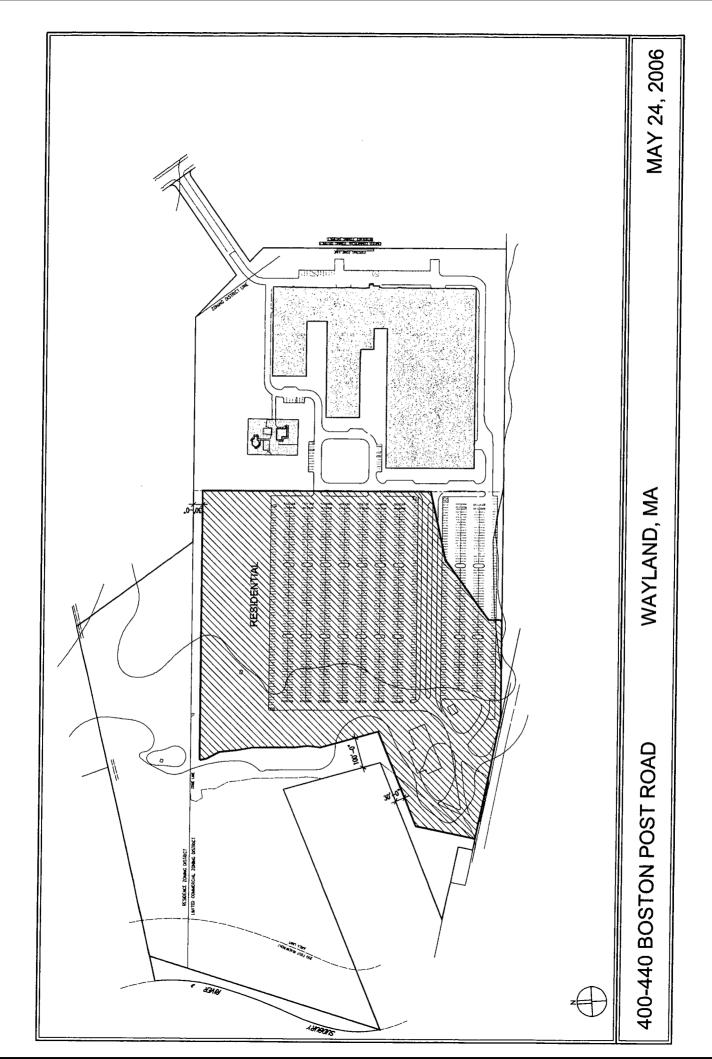
