We hereby submit a copy of this petition, signed by more than 500 Wayland residents and neighbors who oppose the current plans to develop 150 Main Street. The project presents significant safety and traffic concerns, and is out of scale with and inappropriate for our residential neighborhood. We respectfully request that you give serious thought to our concerns as Wayland citizens and business owners and honor our requests.

As we collected signatures for these petitions, we heard many comments with a central theme: "The safety of our neighborhood and our families is threatened by a desire to increase the footprint of commercial development in the most thickly settled residential area in town. Who will profit? Who in Town is looking out for **US**?"

We ask you two questions: "Don't these plans run counter to the Planning Board's mission statement?" The Planning Board's mission statement says:

#### Sarkis,

I attended the planning board meeting last night and I am in favor of developing the parcel. My largest concern is making sure the traffic is dealt with correctly. I am happy to hear that a traffic study is being conducted and look forward to the findings. My comments to the site plan are below.

- 1) Have the applicants sent the site plan to MA DOT for review and approval? With RTE 27 being a state road, DOT will need to weigh in especially on the "right-in-right out" and any signal work or traffic lane work.
- 2) I am concerned about the fact that the intersection on the 10/13/12 site plan calls for the "existing signal, sidewalk & curb. It is my opinion that this intersection should be brought up to current DOT standards with a new signal complete with pedestrian pedestals, new crosswalks, and new sidewalks with handicapped ramps complete with tactile warning strips. This development will clearly impact the intersection and at a minimum they should be required to complete the items stated above.
- 3) With the town's recent struggles with new development and traffic, I think it should be a conditional of approval that all "off-site" work be completed before any tenant in the development is allowed to obtain a Certificate of Occupancy. The "off site" improvements are part of the development approval and if they are not done tenants should not be able to open. I would hate to have another Town Center debacle where the Center opens and the off-site work is not complete (poles in road). The Center then generates traffic that the roads cannot handle. The only people who suffer in that situation are the residents.
- 4) I also had a comment on the landscaping. The 10/13/12 site plan shows a lot of grass. I think a more drought tolerant plan should be developed especially since Wayland has water bans every year. Grass uses a lot of water and the mowing is loud and pollutes. The grass in the "skinny" islands will never survive due to the heat generated in the parking lot even if it is watered. The developer and the residents will benefit by less grass and more trees and perennials.
- 5) The dumpster enclosures are shown to be wooden stockade fence. Wood dumpster enclosures get destroyed by waste haulers because they cannot take a large truck "banging" into it. A more substantial (steel or reinforced CMU) enclosure should be required.

I look forward to a lively development at that corner.

## To the Planning Board:

As the resident and abutter most uniquely impacted by this development, I welcome responsible and safe development at the Finnerty's site. Over the past recent years the building and landscaping have fallen into major disrepair. The property has become an eyesore for those that live in and visit the area, as well as those that drive through. Since I have lived here, residents and commercial ventures have harmoniously co-existed. I wish that to continue.

I urge the Planning Board to keep in mind it's mission as this project proceeds. In particular, e are dedicated to making our town a better place to live - a place where people want to raise a family and have their children raise their children.
