# Purpose of the Hearing

To adopt the Town's Tax Policy by allocating or classifying the tax levy among the property types.

# Action Required by the Board of Selectmen

- Vote to maintain a single tax rate or shift a portion of the tax levy from the Residential class to the Commercial / Industrial and Personal Property classes.
- 2. Vote to whether adopt a residential exemption.
- 3. Vote to whether adopt a small commercial exemption.

# Property Assessment Review

- Fiscal Year 2022 was an Interim Valuation Year for the Assessing Department with the Department of Revenue (DOR) certifying assessed values on December 1, 2021.
- The average residential single-family assessment increased from \$800,115 to \$838,491, an increase of 4.8% from the Fiscal Year 2021 assessments.
- This change was based on sale prices for properties selling in CY 2020.



# New Growth

- New Growth is defined by the DOR as a dollar increase in the annual levy limit that reflects additions to the community's tax base since the last fiscal year.
- New Growth was certified on December 1, 2021 as \$16,456,470 in Assessed Value, or \$304,774 in Tax Levy Growth (based on the FY21 tax rate of \$18.52).
- New Growth in FY 2021 was \$18,431,430, resulting in a decrease of 12.0% in Fiscal Year 2022. This decrease is the result of minimal building activity and Covid related inactivity in the Spring of 2021.

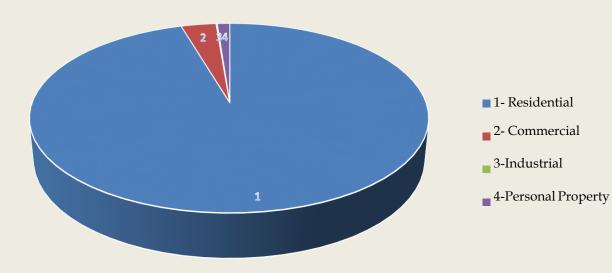

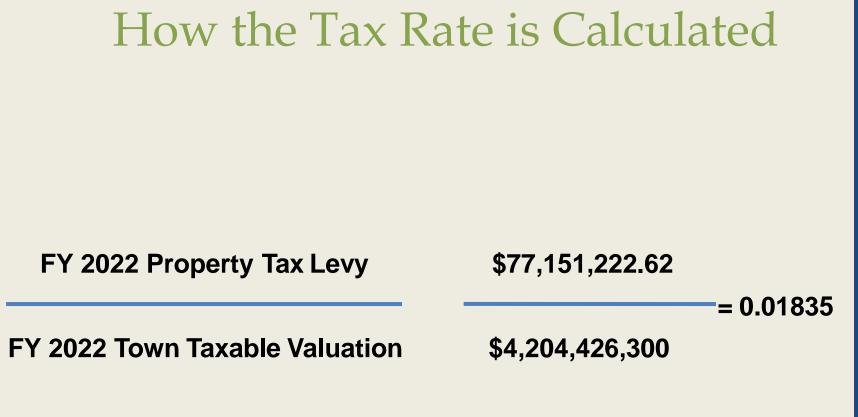

# **Percent of Levy**





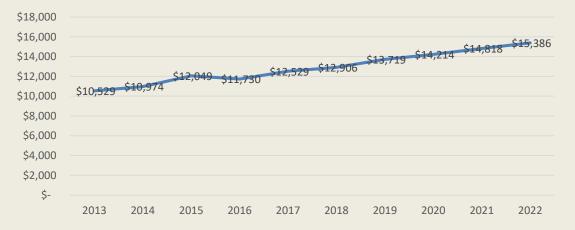

Wayland's percentage of Commercial, Industrial and Personal Property Values has historically been at 5% or less of the total valuation of the Community.

Wayland remains a residential community.

# Selection of Minimum Residential Factor

- A residential factor of 1 will result in the taxation of all property at the same rate (single tax rate).
- A residential factor of less than 1 increases the share of the levy raised by Commercial, Industrial and Personal Property (CIP) owners and reduces the share paid by residential property owners (split tax rate).
- Since 95.2097% of Wayland tax revenue comes from Residential, a slight reduction for the residential properties would put a large increase on CIP properties.
- The minimum residential factor for the Town of Wayland for Fiscal Year 2022 is 97.4843, as determined by the MA Department of Revenue.
- Fiscal Year 2021 had only 115 out of 351 communities voting to have a split tax rate.

# Residential Factor / Split Rate

- MGL Ch. 40 § 56 allows a shift of up to 150% of the tax burden between the classes of property.
- Adoption of a Residential Factor(RF) of 1.0 results in a single tax rate.
- The Town of Wayland has always taxed property equitably with a single rate.

# Selection of Open Space Discount

• There are no parcels in Wayland currently classified as open space.

• Open Space is defined in Massachusetts General Law as:

MGL Chapter 59 Sec 2A(b) "Class two, open-space", Land which is not otherwise classified and which in not taxable under the provisions of chapters sixty-one, sixty-one A or sixty-one B, or taxable under a permanent conservation restriction, and land not held for the production of income but is maintained in an open or natural condition, which contributes significantly to the benefit and enjoyment of the public".

- In Wayland, forty (40) parcels participate in the Chapter Land Program under MGL Chapters 61, 61A and 61B, which results in more savings than if they were designated as Open Space.
- Under the Chapter Land program the discount ranges from 75% to 98%.
- The open space discount has a maximum discount of 25%.

# **Residential Exemption**

- Must be owner-occupied, primary residence to qualify.
- Must apply annually.
- The reduced value remains within the residential levy percent resulting in a higher residential rate.
- All residential properties above a "break-point" value would see an increase in taxes.
- Only 15 of 351 communities adopt a residential exemption:
  - Barnstable, Boston, Brookline, Cambridge, Chelsea, Everett, Malden, Nantucket, Provincetown, Somerville, Tisbury, Truro, Waltham, Watertown, Wellfleet

# **Residential Exemption Detail**

- Average residential value = \$838,491 x 10% = \$79,726 reduction per property.
- Estimate of Eligible properties = 4,424 x \$79,726 = \$352,705,858 value reduced from residential class.
- Total residential value = \$34,003,020,148 \$352,705,858 = \$3,650,314,290 which is the remaining value in the residential class.
- \$73,455,420 = levy to be borne by residential class.
- \$73,455,420 / \$3,650,314,290 x 1000 = \$20.12, which would be the residential tax rate if the exemption is adopted.
- All residential properties valued above \$ \_\_\_\_\_\_ would see an increase in taxes.

# Granting a Small Commercial Exemption

- The Board of Selectmen may adopt a small commercial exemption.
- This exemption is for commercial parcels (property class three) occupied by businesses with an average annual employment of not more than ten people during the previous calendar year and with assessed values of less than one million dollars.
- The intent of the exemption is to give a tax reduction to small commercial property owners at the expense of the larger commercial and industrial parcels.
- Selectmen can choose an exemption that reduces the taxable valuation of each eligible parcel by a percentage of up to 10%.

# **Classification Vote Summary**

- 1. Selection of a Minimum Residential Factor
  - A Factor of 1 yields a single rate.
  - A single rate for FY2022 would result in an estimated \$18.35 rate.
- 2. Vote on whether to adopt a Residential Exemption
  - With a low number of non-owner occupied properties, this shifts a portion of the residential levy from lower-valued residential properties to higher valued properties.
  - Only 15 communities in the Commonwealth have a Residential Exemption.
- 3. Vote on whether to adopt a Small Commercial Exemption
  - This exemption is for commercial properties valued under \$1 million and occupied by business(s) with less than ten employees.
  - This exemption benefits property owners, typically not small business tenants.
  - This shifts up to 10% of the value of those properties to other commercial and industrial properties.

# § 19-3

Finance Committee reports. [Amended 5-5-1983 ATM by Art. 21; 5-1-2000 ATM by Art. 17]

The Board of Selectmen, after drawing a warrant for a Town meeting, shall immediately forward a copy thereof to each member of said Finance Committee, which shall consider all articles in the warrant and make such report, in print or otherwise, to the Town meeting as it deems for the best of the Town. In gathering information to prepare its report, if any, relative to an article, the Finance Committee shall meet with the party or parties that proposed the article and concurrently with others who want to comment thereon, and shall publicly post notice thereof on the Town's principal official bulletin board at least 48 hours, including Saturdays but not Sundays and legal holidays, prior to such meeting. However, if the Finance Committee's report on any article exceeds 30 words in length, excepting an article which requests approval of the Town's itemized, omnibus operating budget for the ensuing fiscal year, then that report on said article shall conclude with a summary of reasons favoring the article that were considered by the Finance Committee in its deliberations and a separate summary of reasons disfavoring the article that were considered by the Finance Committee in its deliberations. The Committee shall also make an annual report which shall be published as part of the Annual shall include recommendations Town Report and which for appropriations for the ensuing year, a budget and such further

recommendations regarding the finances of the Town and action in regard thereto as seems to such Committee to be necessary and appropriate.

# § 19-1. Finance Committee. [Amended 5-6-1992 ATM by Art. 19; 5-10-1999 ATM by Art. 25]

There shall be a committee called the "Finance Committee" appointed by the Board of Selectmen as hereinafter provided. Such committee shall consist of seven registered voters who shall serve without pay and none of whom during his or her service on such Committee shall hold elective or appointive Town office having to do with the appropriation or expenditure of Town money. Members shall serve terms of three years, such that the terms of two or three members shall expire each year. Appointment to fill unexpired terms shall be made by the Board of Selectmen as vacancies occur.

# § 19-2. Budget; capital improvement program. [Amended 5-6-1992 ATM by Art.20]

The Finance Committee shall prepare the omnibus operating budget of the Town and submit it at the annual Town meeting. It shall also prepare and present to the annual Town meeting a five-year capital improvement program for the Town, which shall include the construction and reconstruction of capital assets (such as municipal buildings, recreational facilities, roads and landfills) and acquisition of land, equipment and vehicles and other personal property, and shall make recommendations to the appropriate authorities proposing such improvements.

# § 19-3. Finance Committee reports. [Amended 5-5-1983 ATM by Art. 21; 5-1-2000 ATM by Art. 17]

The Board of Selectmen, after drawing a warrant for a Town meeting, shall immediately forward a copy thereof to each member of said Finance Committee, which shall consider all articles in the warrant and make such report, in print or otherwise, to the Town meeting as it deems for the best of the Town. In gathering information to prepare its report, if any, relative to an article, the Finance Committee shall meet with the party or parties that proposed the article and concurrently with others who want to comment thereon, and shall publicly post notice thereof on the Town's principal official bulletin board at least 48 hours, including Saturdays but not Sundays and legal holidays, prior to such meeting. However, if the Finance Committee's report on any article exceeds 30 words in length, excepting an article which requests approval of the Town's itemized, omnibus operating budget for the ensuing fiscal year, then that report on said article shall conclude with a summary of reasons favoring the article that were considered by the Finance Committee in its deliberations. The

Committee shall also make an annual report which shall be published as part of the Annual Town Report and which shall include recommendations for appropriations for the ensuing year, a budget and such further recommendations regarding the finances of the Town and action in regard thereto as seems to such Committee to be necessary and appropriate.

# § 19-4. Estimates of expenses and income. [Amended 4-3-2003 ATM by Art. 37; 5-3-2004 ATM by Art. 11]

The various Town boards, officers and committees charged with the expenditure of Town money shall, not later than the 15th of December in each year, file with the Clerk of the Finance Committee detailed estimates of the amounts deemed necessary for the administration of their respective board, office or committee for the ensuing fiscal year, with explanatory statements of the reasons for any changes from the amounts appropriated for the same purpose in the preceding year. They shall also file estimates of all probable items of income which may be received by them during the ensuing year in connection with the administration of their board, office or committee. One month prior to the 15th of December in each year, for all Town boards, officers and committees under the jurisdiction of the Board of Selectmen, the Town Administrator shall submit to the Board of Selectmen detailed estimates of the amounts deemed necessary for the administration of all such boards, offices, or departments for the ensuing fiscal year, including both capital and expense items. The Town boards, officers and committees under the Board of Selectmen's jurisdiction shall be defined as those boards, officers and committees appointed by the Board of Selectmen in accordance with the Town's by-laws and/or state law. The budget submission should include explanatory statements of the reasons for any changes from the amounts appropriated for the same purpose in the preceding fiscal year. For each such Town board, officer, committee and department under the Board of Selectmen's jurisdiction, the Town Administrator shall also, as part of the submission, file estimates of all probable items of income which may be received by them during the ensuing year in connection with the administration of each such board, office, committee or department. For the Town boards, officers, committees and departments under the Board of Selectmen's jurisdiction, the Town Administrator shall submit preliminary budgets to the Finance Committee by December 15th of each year. Prior to January 15 of each year, unless another date is agreed to, the Town Administrator shall review and make recommendations to the Board of Selectmen with respect to the budget requests, including both capital and expense items, and income estimates of all other Town boards, committees, offices and departments. except for the School Committee. In addition, the Board of Selectmen shall, no later than the 15th of January in each year, unless another date is agreed to, make both a capital and expense budget recommendation to the Finance Committee for the ensuing fiscal year for each Town board, officer and committee under its jurisdiction.

### § 19-5. Warrant articles involving appropriations or expenditures.

A. Any person presenting an article for insertion in the warrant for any Town meeting which involves the appropriation or expenditure of money by the Town shall also submit an estimate of the expected amount of money to be expended or appropriated to carry out the purpose of the article. Said estimate, together with the name of the person or persons submitting such article, shall be transmitted by the Board of Selectmen to the Finance Committee. B. In order for funds to be made available by the Town for contribution to the Other Postemployment Benefits Trust Fund ("OPEB Trust Fund"), such funds must be appropriated by Town Meeting pursuant to a specific Town Meeting warrant article other than the omnibus budget article. [Added 10-3-2012 STM by Art. 5]

### § 19-6. Salaries and compensation.

No Town officer, no salaried employee of the Town or member of any committee appointed to act for the Town and no agent or employee of such officer, employee or committee shall sell materials or supplies to a board or committee of which he/she is a member or receive any compensation or commission for work done by him/her as such officer, employee or member of a committee, except his official salary and the fees provided by law, without permission of the Board of Selectmen expressed in a vote which shall appear in its records, together with a statement of the reasons therefor.

### § 19-7. Acquisition of vehicles. [Added 5-13-1999 ATM by Art. 43]

No vote at any Town meeting to appropriate funds for the acquisition of any vehicle valued at \$10,000 or more for the Park and Recreation, Highway or Water Departments shall be in order unless the Town's procurement officer has prepared a description of the vehicle suitable for inclusion in an invitation for bids for a procurement contract under MGL c. 30B, the Uniform Procurement Act, and placed such vehicle description on file with the Town Clerk for public inspection at least seven days before the annual meeting and at least 14 days before any special Town meeting.

### § 19-8. Board of Assessors. [Added 5-8-2000 ATM by Art. 28]

- A. Annual Report. The Board of Assessors shall:
  - (1) Make an annual report of sales of properties sold in Wayland available to the public by submitting it to the local newspapers, having it posted on the Town's Internet Web site and providing copies at the Town Library. The report shall describe the semi-annual increase or decrease in the average sale price of residential properties in Wayland.
  - (2) Prepare, as part of the reports to be heard under the annual Town meeting "Hear Reports" article and the Annual Town Report a report for the previous six calendar years that provides:
    - (a) The number of annual abatement requests filed with the Board of Assessors;
    - (b) The annual number of abatements granted by the Board of Assessors;
    - (c) The annual average value of the abatements granted by the Board of Assessors;
    - (d) The number of annual abatement requests filed by Wayland property owners at the Appellate Tax Board with respect to Wayland properties;
    - (e) A list by property of the dollar changes in each assessment granted as a result of Appellate Tax Board decisions; and

- (3) Prepare, as part of the report to be heard under the annual Town meeting "Hear Reports" article and the Annual Town Report, a report for the previous calendar year that states the number of residential properties that were due for inspection, the number of properties actually inspected, the number of properties for which an internal inspection of the dwelling was conducted, the number of residential properties sold, the number of sold properties for which an internal inspection was conducted, the number of properties inspected in response to a grant of a building permit, and any other criteria requested by the Board of Selectmen or its designee that will provide guidance to the Town as to the effectiveness of the assessment process.
- B. Quarterly reports. The Board of Assessors shall prepare and provide to the Board of Selectmen quarterly reports detailing the progress in implementing the Recommendations of the Assessment and Valuation Study Committee contained in Article 27 of the Warrant for the 1999 Annual Town Meeting and shall submit these reports to the Board of Selectmen or its designee for posting on the Town's Internet Web site.
- C. Public hearing. The Board of Assessors shall hold a public hearing annually to listen to taxpayer concerns and questions regarding the assessment process and the services provided by the Assessors' Office. The Board of Assessors shall ensure that adequate time is provided for the hearing and that the agenda is set so that a hearing occurs where citizens are given a reasonable amount of time to voice their concerns.
- D. Increased valuation information. After each revaluation, the Board of Assessors shall send, within 30 days of the actual tax bill, a separate, reasonably detailed written explanation of the actual basis for the increased valuation for each residential property for which the new valuation percentage increase is eight percentage points or more above the Town-wide average residential increase in percentage points. Town-wide average residential increase shall be based on a data set that includes all those revalued residential properties for which no building permit has been issued between the current revaluation and the prior valuation.
- E. Change of assessed valuations. [Added 5-12-2004 ATM by Art. 40]
  - (1) After the Board of Assessors has made a decision concerning a taxpayer's abatement request of change of real property assessment, included with the decision, on the form provided by the state that is sent to the taxpayer, will be notice of any change in the data on that property record card and the dollar effect in assessment for each change in the section that states "reason for abatement."
  - (2) If the Board of Assessors deems appropriate a change in the property record card's market data, either as a result of a visit to a property in Wayland that takes place once every decade to be sure that information on the property record card is accurate, or the visit is the result of a sale of, or a renovation to a property, or as a result of sales since the last town-wide revaluation (such as, but not limited to a change in assessment neighborhood) that data change shall be reported to the real property owner at the time that the new data will cause a change in the assessed value of said property.

When the assessed valuation of a property changes, as occurs at an annual, biannual, or triannual town-wide revaluation, the town shall make the following information available at the Assessor's desk and on the Town website in table form: all of the influence factors that the Board of Assessors uses to value real property in Wayland such as, but not limited to: style of house, age, grade, value per square foot, CDU (condition/desirability/ utility rating), heating type, fuel, heating system, finished basement living area, porches, open porches, wood decks, story height, swimming pool, barn, tennis court, traffic influence. All pertinent constants and coefficients shall be stated.

- (3) Additionally, available at the desk and on the Town website shall be: a general description of the valuation algorithm, definition of special terms, and a detailed description of the specific implementation.
- (4) When the assessed valuation of a property changes as occurs at an annual, biannual, or triannual town-wide revaluation, the town shall make the following information available at the Assessor's desk and on the Town website: a table displaying the prior and new land valuation factors by assessment neighborhood with a map identifying and displaying all assessment neighborhoods.
- F. Community Preservation Act surcharge exemptions. Applications for exemptions from the Community Preservation Act surcharge pursuant to Massachusetts General Laws Chapter 44B, Section 3(e)(1), must be filed with the Office of the Board of Assessors no later than three months after the issuances of the actual real estate tax bill. [Added 4-10-2008 ATM by Art. 24]
- G. Local Circuit Breaker Program. Applications for senior tax relief under the Town Circuit Breaker program must be filed with the office of the Board of Assessors no later than April 1 of the year to which the tax relates, or within three months after the bill or notice of assessment was sent, whichever is later. [Added 4-13-2009 ATM by Art. 13; amended 11-14-2017 STM by Art. 7]

#### § 19-9. Public hearing on tax rate. [Added 4-9-2012 ATM by Art. 19]

Before the Town submits its proposed tax rate(s) for any fiscal year to the Commissioner of Revenue for approval pursuant to General Laws Chapter 59, § 23, all boards and officials whose names appear on the Tax Rate Recapitulation document as approving or certifying the information contained therein, or their representatives, shall collectively conduct a public hearing to give interested citizens an opportunity to be heard and to ask questions concerning the tax rate(s). Forty-eight hours at least before the hearing, the proposed Tax Rate Recapitulation, together with the date, time, and place of the hearing, shall be posted on the Town's website and in a conspicuous place in the Wayland Town Building.

#### § 19-10. Revolving funds. [Added 4-2-2017 ATM by Art. 5]

A. Pursuant to MGL c. 44, § 53E 1/2, as amended, the following revolving funds are authorized, shall be accounted for separately from all other monies in the Town, and each fund shall be credited with any fees, charges or other receipts from the

programs or activities supported by the respective revolving fund: [Amended 4-2-2018 ATM by Art. 6]

- B. Any Town board authorized to administer a revolving fund shall approve user fees, calculated upon the cost of providing the service or program, which shall include, but is not limited to, costs for associated maintenance, capital improvements, wages and employee benefits and indirect costs.
- C. The Annual Town Report shall include, for each revolving fund, an accounting of the fiscal year-end revenues, expenses, balances and Town Meeting voted limit of expenditure.
- D. In connection with the annual Town budget cycle, the entity authorized to spend each fund shall submit to the Finance Committee an estimated end-of-year balance for the current fiscal year and a revenue and expense plan for the upcoming fiscal year.

2021 COA Update to BOS (Spring Town Meeting – Thanksgiving)

May 2021 Spring Town Meeting

The Public Ceremonies Committee named the Wayland Council on Aging as the recipient of the 2021 Lydia Maria Child award for public service. As a Town Department, we were both delighted and humbled by the award as the nominations are made by Wayland residents who felt that our work in the past year had made a positive difference in their lives and the lives of other seniors in Town.

- PROGRAM UPDATE:
  - The 10<sup>th</sup> Annual COA 5 week Summer Concert series in the courtyard was enthusiastically attended by residents of all ages. The COA was able to fully fund this series with the support of community sponsors and the Wayland Cultural Council.
  - In-person, hybrid and zoom programs are continuing to be offered to accommodate the varying comfort levels that residents have with the fluctuating covid infection rate. Our In-person program capacity limits have been lowered to more safely accommodate attendees. Unfortunately reducing the number of reservations for an event, creates wait lists for residents.
  - COA partnered with Hansen Farms and BayPath Elder Services to offer a farm to table experience with a CSA delivery of farm produce. COA volunteers delivered the produce throughout the summer. The variety of produce available encouraged recipients to research and try new recipes. Program participation was open to all seniors. A lottery was held due to the extraordinary interest.
  - The restructured Senior Property Tax Work-off program started late summer. Over 25 residents are currently participating in the program to assist Town Departments in exchange for a credit to their property tax liability. Placement of volunteers was more difficult this year given Covid concerns.
  - The COA has worked with the Health Department several times to help seniors get scheduled for flu shots, vaccinations and boosters. Most recently COA sent an eBlast to seniors as well as a Voice Mail alert on the telephone to reach seniors who did not use computer or could not register themselves for an appointment. The robo call to seniors generated non-stop calls to the COA and the Selectmen's Office. COA staff spend approximately 12-15 minutes on the phone with each resident to input all the information required to register for an appointment.
  - A variety of lectures and luncheons took place this Fall. The history of Oktoberfest was celebrated with soft pretzels, apple cider, non-alcoholic beer and a Great Course lecture on the history of beer starting with the Sumerians, Egyptians and Medieval Benedictines A Thanksgiving Luncheon was offered in the COA as well as a Drive Thru Grab N Go Thanksgiving dinner for those preferring to dine at home in a less crowded setting. Thanksgiving expenses including the acoustical guitarist were offset by a generous donation from the Friends of Wayland COA, Inc, a 501(c)3 organization.
  - COA has continued to create <u>zoom</u> programs with high participation including discussion groups, art appreciation and armchair travel. Armchair travel encourages residents to

share their photographs and travel experiences with other attendees. <u>Hybrid</u> programs – like Way-Gen genealogy interest group allows both in-person and remote participation. The "Owl Meeting Pro" an innovative 360 degree camera and microphone allows all residents attending to feel an integral part of the discussion when using a 50 inch monitor. The technology of the Owl Meeting Pro greatly enhances both the audio and visual experience for participants. The purchase of an "Owl Pro" was a donation of the Friends of Wayland COA.

- The COA 16 passenger handicapped accessible van has been transporting residents for grocery shopping and to locations like Castle Island and the Isabella Stewart Gardner Museum for the Titian Power: Myth and Power exhibit. The COA van is used to transport residents to the BSO open rehearsals and other area locations within a 60 minute radius of Wayland.
- MAPC awards secured by the Wayland COA have currently funded over 600 taxi rides for residents in need of transport to medical appointments. It has been vital to help residents receive treatments at local, regional or Boston area locations.
- COA's 33<sup>rd</sup> Annual Children's Holiday Shoppe was cancelled again this year given the large number of elementary school age children and covid concerns. Approximately 250 children shop at the annual fair that is manned by 50+ volunteers. Approximately 100+ parents and their pre-k non-shoppers wait for up to two hours in the large Hearing Room for their "shoppers to return with their assigned elf (a Middle or High School student) and the child's thoughtfully purchased wrapped gifts". It is an extraordinary event but just not feasible given Covid concerns and vaccinations at this time.

#### SERVICE UPDATE:

- Over 400 COA health insurance review appointments during Medicare Open Enrollment (Oct. 15 – Dec 7) have been scheduled and will take place by Dec. 7 Appointments were offered, in-person, via zoom or by telephone. COA staff process the requests and cancellations, mail appointment confirmations and intake sheets, confirm appointments
- The COA is hoping to re-open the medical equipment loan closet in 2022. We are currently securing dedicated space to monitor inventory and equipment exchange. At present, only transport chairs are being loaned short term. When the space is available for use, COA will then send equipment out for cleaning and safety checks. Equipment has not been loaned since pre-pandemic.

#### ➢ CHALLENGES

- Staffing: COA staffing at this time is currently at only 3.3 FTE. COA is a staff driven program and service department serving residents in person and remotely. With an increasing number of seniors accessing the COA, this is an overwhelming challenge at 3.3 FTEs. Transitioning from a band-aid staffing pattern to a staffing structure that will best serve the senior community going forward is critical.
- Space: Inadequate square footage and non-contiguous space challenges our ability to serve our target group appropriately
- Transportation: The MAPC grant funds will be exhausted in the next 8 weeks. This service has been critical to many residents. For some, it was a 5am appointment for

dialysis. For others it might have been radiation treatments. A third funding cycle with MAPC is anticipated – but not until Spring. At this time we are advising residents about alternative options for transport ...from use of COA taxi vouchers to making reservations for the MWRTA shared ride system. The COA "FISH" volunteer ride service to medical appointments has not been re-instated due to Covid related concerns.

- Parking: Residents complain regularly as they loop through the parking lot to look for an available space or struggle with the parallel parking spaces in the front of the building. Residents are frustrated with the coned off spaces, the 16 school buses, the storage trailers. From their standpoint they see a row of parking eliminated on the far side of the back parking lot to store the buses. The double row of parking adjacent to that rear bus parking, is coned off completely to allow for the bus turning radius to park. That alone reduces the spaces in the back parking lot by ~54 vehicle spaces: ~18 spaces lost from the back row, 36 spaces lost from the turning radius area. It is impossible to park when we have the larger group events. The front of the building is also a challenge if we are hosting a larger event in the Large Hearing Room. Residents who are unsteady and not able to walk long distances are unable to park in the parallel parking spaces out by Rte. 27 and the distance from the back parking lot, through the Town Building often requires wheelchair transport.
- \
- ▶ FIRST QUARTER 2022 Program Service projection:
  - AARP IRS Partnership with Wayland COA
    - Planning for the 2022 AARP-IRS Tax Return Prep serving lower income seniors has begun. Last year we were able to accommodate approximately 140 seniors at a time when many COAs had not even been approved to launch their AARP tax prep program. Previously Wayland COA worked with the regional AARP/IRS tax coordinator to create a mitigation plan during the pandemic. Based on that plan, AARP selected Wayland to be part of their test sites. The traffic flow, table placement, temperature stations and signage combined with germ barriers made both clients and preparers feel safe. As this is a critical service, we are hopeful that AARP-IRS will once again approve volunteer service for seniors at Wayland Town Building.
  - COA will submit grant applications for MAPC taxi ride 3<sup>rd</sup> Round funding if available this spring. A BayPath application for transportation funds will also be requested to bridge us should a critical need surface with a resident. We will also request BayPath funding consideration for residents who live alone and are in need of outpatient treatment requiring sedation. Those residents are unable to be released unless an experienced caregiver or family member is accompanying them on discharge. The grant award would be for the caregiver transport to the hospital and the return trip with the discharged resident.
  - Fit Club memberships have increased 20%. Participants have embraced the ease of registration and the value added with an all-inclusive membership allowing participants to take advantage of all fitness offerings; in-person as well as zoom.
  - We approach the next quarter with cautious optimism about our ability to provide in-house programming for older adults as well as transportation services. We will take guidance from the Town Administrator and the Health Director re: Covid guidelines for the fluctuating infection rate.

#### Fall Means It's Time to Check Your Smoke and CO Alarms By Todd Winner, Wayland Fire Dept., Senior SAFE Team

The end of Daylight Saving Time is fast approaching ("fall back" on Sunday, Nov. 7), which means two things: 5pm feels like 9pm and you should test your smoke and carbon monoxide alarms to make sure they are working properly. All alarms manufactured today have a "born on" date to help determine when they should be replaced. The average life span of a smoke alarm is ten years, and six years for CO alarms.



Properly working smoke alarms are responsible for saving thousands of lives, so you should be vigilant about testing them for proper function. A chirping alarm not only drives my two dogs crazy but usually means the battery needs to be replaced or the alarm could be malfunctioning and needs immediate replacement. If you cannot reach your alarm to test, you could use a broom handle to push the test button or ask a family member or neighbor to do it for you. There are all different kinds of smoke alarms out there so it's important to know and understand what kind are in your home.

Because newer homes today are built to be more efficient and are better insulated (buttoned up) compared to houses even ten years ago, the air transfer between outside and inside has

decreased greatly. This decreased air transfer is great for keeping heat in and cold out in the winter, but also allows carbon monoxide or "CO" to build much faster in homes, which is bad. A dangerous buildup of CO in the home is usually due to the home's heating system not properly venting to the outside and filling up the home. Carbon monoxide is a colorless, odorless gas, so when a CO alarm goes off, don't ignore it.

In the event your smoke or carbon monoxide alarm sounds and you don't know the cause, **don't ignore it**, immediately exit the home and dial 911.

## Medicare Open Enrollment is October 15—Dec. 7

Medicare plans change every year and Open Enrollment is the time period to decide on your coverage for 2022. For many people, this is the only time each year to make any changes to your current selections. SHINE counselors are trained volunteers who provide free Medicare counseling to help you compare options.

#### SMOC Program Offers Help Covering the Cost of Winter Heat

Beginning November I, households with limited income may be eligible for help with home heating bills this winter through the Low Income Home Energy Assistance Program (LIHEAP). Eligibility is based on the total gross annual income for an entire household: \$40,951 for households of one, and \$53,551 for households of two. Anyone who received SMOC Fuel Assistance last year should receive a renewal packet in the mail during September and October. Please submit your renewal information promptly to

avoid the seasonal rush. Follow the instructions, sign the pre-filled application and mail all requested documents. To learn more, call the COA or South Middlesex Opportunity Council (SMOC) at 508-620-2342 or email <u>fuel-docs@smoc.org</u>. Applications will be processed remotely.

Currently free of charge, normally \$2, \$3 or \$5 each way based on destination. Pre -register with MWRTA at 508-820-4650. Registered riders must make reservations at least 48 business hours prior to travel date.

**MEDICAL TAXI VOUCHERS:** For Waylanders 60+ or disabled at any age. Purchase discounted taxi vouchers in advance from the COA for taxi trips to medical appointments or medically-related activities at the COA. Administered through JFK Transportation; discount is 40% off metered fare. Boston travel is a flat rate of \$42 each way. Tips expected in cash. Schedule rides directly through JFK 508-653-4500.

#### AN UPDATE ON OUR TAXI PROGRAM

Our grant-funded taxi program has been an important service we've been pleased to offer residents since July 2020, thanks to two rounds of grant funding from the Metropolitan Area Planning Council. In that time, we have provided more than 600 taxi trips to medical appointments, free of charge.

We anticipate that our funds for this program will be depleted within the next several months; we do not know if MAPC will offer more grant opportunities. In anticipation, we are exploring alternative transportation programs.

We also recommend using MWRTA's Dial-A-Ride which is currently free of charge. This shared-ride service can be used for medical and non-medical travel. We will keep the community informed about our future plans to help meet transportation needs for Wayland's senior residents.

#### **Q&A with the COA** What would you like to know? Just ask us!

**Q.** Where can I get some help using my cellphone or laptop? How can I "Zoom"?

**A.** Technology can help us connect with other people or with information in new and convenient ways. But it can also be a source of stress. And not being able to use some types of technology can limit your access to programs or events you might like to join.

In years past we have tapped into the natural tech skills of high school students, who are often happy to tutor their elders in how to use their devices. If you would be interested in receiving help, please call the COA and let us know. We will be happy to facilitate such arrangements!

## Youth & Family Services Update 11/29/21

## • Clinical Capacity

- Wayland Y&FS continues to see a steady increase in individuals and families seeking support and clinical care. During the summer moths, Y&FS was able to welcome new clients for ongoing/long term clinical services. As school returned to session in the fall, we experienced a steady increase in requests for service. New requests have been seeking services related to substance use, anxiety, depression, impulse control, feelings of uncertainty, social anxiety and other presenting factors. We are currently able to meet the demand, but due to limited available space, we have shifted to a consulting model with new clients. In the consulting model, we provide an intake/evaluation as well as three follow up sessions. At the end of the three sessions we make an evaluation to continue services and/or make referral for continued care.
- In the month of November, we have averaged 6 new requests for service per week. This is equivalent to our average monthly requests for service.
- Clinical services continue to be offered via zoom and other virtual platforms. Clients and staff have expressed this as their current preferred meeting preference at this time. In addition to virtual individual services, in-person social skills groups have resumed at both the Middle School and High School.

#### • Substance Use Prevention & Education

- Wayland Youth & Family Services/WaylandCares has continued to partner with Wayland Public Schools to provide both proactive education through the wellness department and intervention services in conjunction with the school administration. In the fall of '21, we were able to meet with every 9<sup>th</sup> grade wellness class to provide vaping education and discussion. As we continue to see an increase in youth vaping, we are focused on a multi-pronged approach to educate both youth and adults, in hopes of seeing a reduction in vaping.
- We will be holding a public vaping education forum at Wayland High School on Wednesday, December 8<sup>th</sup> at 7pm. This forum will be a hybrid (in-person and live streamed via zoom) presentation, focused on current data, local observation, health risk facts, talking points and tips for parents and general prevention strategies. The event will be recorded and made available online as an educational resource.
- With an increase in youth substance related incidents, we have retooled the Diversion Program in conjunction with the Wayland Police Department. Through this program, we have been able to work with 13 youth and provide a specific and intensive educational opportunity. In addition we have youth working collectively with

Y&FS to develop community campaigns addressing social norms and social host liability.

- Y&FS is developing a series of newsletters to provide monthly topics and talking points for parents addressing substance use with young people in their life.
- Violence Prevention
  - Y&FS continues its work with the Domestic Violence Round Table and The White Ribbon Campaign. In the month of October we assisted in designing and distributing community banners for Domestic Violence Awareness Month, participated in a community walk to end domestic violence and participated in a community vigil.
  - The White Ribbon Campaign is in the process of planning two separate community education events for February and March.
  - Y&FS continues to support the work of the WPS task force to address relationship violence and sexual abuse/harassment. Y&FS will continue to work with school staff and community members to follow up on the work of REACH and Focus Groups that were conducted in the spring of '21.

## • Current Youth Leadership Work and New Staff

- Y&FS welcomed Megan Wohlfarth on board as our new Substance Prevention Outreach Coordinator in November. Megan is currently working with WMS to begin offering in-person Youth Leadership Group programing and opportunities to the entre school population.
- The WHS SADD Chapter continues to work under the guidance of John Berry and in partnership with Y&FS. SADD members are currently assisting Y&FS in developing a Social Host Liability Campaign, as well as planning on providing updated data presentations from the MetroWest Adolescent Health Risk Survey in the spring of 2022.
