CONSERVATION CLUSTER DEVELOPMENTS

To determine whether the Town will vote to amend Chapter 198 of the code of the Town of Wayland, the Town's Zoning Bylaw, by making the following revisions to Section 1803.1:

[Key to changes: <u>underlining</u> denotes additions; strikethroughs denotes deletions]

1. The proposed amendments are intended to clarify the total number of dwelling units on a tract of land, by removing the calculation section and further clarifying by requiring a conventional subdivision in conformity to prove number of units allowed in a development. The Bylaw amendment also has new language that defines "open land" and requires that the open land maintain a minimum lot shape factor not greater than 50.
