The Town of Wayland is issuing this addendum to provide information that was not provided in the original IFB package, as well as provide clarifications based upon questions received from Contractors relative to the project.

Acknowledgement of receipt of this addendum is required in all submitted bids.

The Town has received questions concerning specific information in the Construction Documents. This addendum provides responses to the following questions:

1. What a day consists of? The contract talks about partial days for billing.

Response: The Town anticipates that the majority of the work, particularly scheduled, will be completed in 8-hour, one day, blocks from 7AM to 3 PM. Typically, a half-day minimum would be the least “partial day”. However, the Town reserves the right to pay in other increments based upon the effectiveness of the work, weather conditions, emergency conditions, etc.

2. What is the 4 hour emergency call adjustment? What equipment / personal does this include? Is this a premium that is added to the other rates? Does it apply per man hour?

Response: This item is to a pay premium when the Town calls an emergency and the Contractor responds within the timeframes set in the specifications. This is a single value to be paid on top of billing for the other items contained in the package. The value is on a per event basis. It is not hourly or to be loaded onto each item individually.

3. Can you also send me the results of your last tree bid?
