Bill Sterling describes the Community Center project, 470k design. 5.27 MIL Construction Alexia Obar asks about the vapor barrier that Raytheon required; Bill Sterling, doesn't know that is true, and describes the AUL history.

7:25 PM LOKER PROJECT, WHS STADIUM ARTICLES

Infill options discussed, under the purview of the PMBC to choose infill material. Brud interested in finding out Conservations jurisdiction. 100 foot buffer from North Pond. Have order of conditions been resolved? Heath – Ongoing.

Bill Cossart – still waiting for EPA report.

Paul Nech - Fessenden School has coconut infill.

Heath – Playability issues with infill other than crumb rubber. Cost difference with Virgin Rubber.

Asa – Committed to BOH to involve them, and research crumb rubber alternatives.

Reed – asked if hard from opposition?

Asa – nothing significant.

Alexia Obar – will you have to cut any trees on Rice Road?

Asa – no, there's a 50' buffer of Conservation land that we won't touch.

Reed- where does the funding come from?

Asa- Prop 2 ½, taxation, or potentially private funding.

Brud – could user fees pay to replace the turf? Brud felt like over 10 year lifespan of the carpet, would likely cover the replacement of the turf.

Alexia – how long do we expect the turf to last?

Heath – currently in the 11th year of the WHS turf, warranties for 12 years.

Reed- funding for the School Projects – Capital Maintenance Accounts, CPC Funds for the swap of Tennis Courts and Softball fields.

Reed- so not all taxpaper dollars?

Heidi – a bulk of it is. CPC is spending less than 500k, won't touch the turf.
