Application of **Howard Ng on behalf of So Ling Cheung (owner)**; for any necessary approvals, findings, special permits and/or variances as may be required in order to increase the gross floor area of a preexisting nonconforming single family dwelling (see right yard setback) by more than 20% (proposed increase of 3966 sf) with additions under the Town of Wayland Zoning By-Laws Chapter 198; including but not limited to: Sections 104.2, 201, 203, 401.1.2, 401.1.3, Articles 7, 8 and §198 Attachment 1 Table of Dimensional Requirements. The property is located at **383 Commonwealth Road** which is in the R-30 Zoning District. **Case #19-15**.
