

## PROJECT DESCRIPTION — SCOPE & IMPROVEMENTS

There are SO many possibilities to make Cochituate Park not just the most used, but the most <a href="ENJOYABLE">ENJOYABLE</a> and <a href="INCLUSIVE">INCLUSIVE</a> recreational space in Wayland!

- Poured-in-place rubber surfacing instead of woodchips to make area accessible to the greatest possible number of users

## PROJECT DESCRIPTION — EXISTING CONDITIONS

- Provides bare minimum for equity, inclusion, and play
- Wheelchair accessible to ONE swing only is not ADA compliant
- No contrasting colors
- Mostly underutilized space
- Playground structures look sad!
- Seating areas not conducive for social and individual use
- Field bleachers not ADA compliant
- Security risk with limited lighting and no surveillance
- Walkways and ramps limited to one area of the park
- Parking lot poses safety risk with one-way in and out

## PROJECT PURPOSE - RELEVANCE & RATIONALE

### Improving Accessibility and Inclusivity at public parks and recreation areas...



- Just as water, roads, and public safety are considered essential public services, parks are vitally important to establishing and maintaining the quality of life in a community, ensuring the health of families and youth, and contributing to the economic and environmental well-being of a community.
- Improving accessibility on playgrounds qualifies as an allowable use of CPA funding under Open Space and Recreation
- Compliance regulations mandate these upgrades

...to provide a space for fun, safe, physical and social interactions for all AGES in Wayland, regardless of ability.

## PROJECT PURPOSE — SUPPORT OF COMMUNITY PRESERVATION ACT

### Intention is to exceed goals and objectives of CPA for Recreation!

The playground we have designed has a specific focus on inclusion. We want there to be a space where not only children of all ages can play but one where tweens and teens feel welcome. Something that invites you in and just screams "come play on me, sit on me, hang out on me, come be who you are." There is an emphasis on ground level accessibility, ground level play, open access without a defined set of stairs for a more open inclusive play experience. There are places to climb but also places to just hang out. There is a built-in aspect of route planning which is shown to be a cognitive and creative way to engage a user's brain especially while they are younger. The unique shape of the design allows for a sculptural feel to the play area which also lends to its inclusive nature making it more multi-generational. Something for all ages to use and enjoy. This playground design also captures the most popular activity on the planet right now which is ropes courses. It is the number one desired activity to have on a playground. We have designed using some unique belting materials that allows for sensory cutouts and light and shadow play. These belts also help the overall accessibility of the structure. If a user has a mobility impairment but can transfer from their assistive devise, the belting has a "receiving feel" and is much softer than a traditional steel deck configuration allowing for a more

comfortable engagement. It molds more to a user's body giving them a higher level of body comfort and mental control. We have also included spinning elements as a sensory addition and calming effect for users. It is also important to have those solitary pieces of equipment where someone can be using it alone if they need to or want to. Balancing activities are present to allow for ground level or elevated play opportunities that engage the entire core. The absence of a true defined access or egress makes this a playground where anyone no matter of ability can enter the structure at their own level and at their own location of choice therefore creating a better place to play alongside your peers rather than creating a space that excludes users. Peer modeling is extremely important for child users of playgrounds as they develop intellectually. By designing this more open concept, it has really opened the peer modeling aspect with almost endless opportunities to play alongside each other, over each other and looking down and interacting with friends, under the top layer while looking up at a peer, and your movement actually impacts the play of others whether you are on the ground using your hands or you are on the structure. You are truly interacting with other children/users which makes this extremely inclusive and universally accessible.

## PROJECT PURPOSE — BENEFITS

# Playgrounds and parks don't only benefit children. Children rarely use playgrounds alone!

### Benefits from improvements to playgrounds and creating other social areas:

- Create equitable gathering places for people of all ages and abilities.
- Children with visual impairments benefit from contrasting colors.
- Parents, relatives, and caregivers with a disability need to safely care for children.
- People with temporary conditions such as broken bones, eye surgeries, or even advanced pregnancy will find it easier to get to and utilize an accessible play area.
- Senior citizens experiencing stiffness or limited range of motion due to arthritis have an easier time participating at an accessible play area with children and grandchildren.
- Less annual material and labor costs with single surface compared to maintaining woodchips
- Potential revenue opportunities if structures built and rented for community or private events

## PROJECT PURPOSE — SUPPORTING DOCUMENTS

### Third party inspection report determined currently <u>NOT</u> ADA Compliant

"<u>Cochituate</u>: PIP rubber was not installed properly. The bevel is too drastic; it does NOT meet ADA, and is also a tripping hazard." (1)



By way of review, although I hade a site visit to the beach, it way my understanding that there were impending changes being made, herefore I did not inspect the site, and removed the site from the invoice. Happy Hollow had 2 inspections – the new equipment [done in 2017] and the 're-visit' of the other equipment at Happy Hollow.

My general impressions are as follows:

Cochituate: PIP rubber was not installed properly. The bevel is too drastic; it does NOT meet ADA, and is also a tripping hazard.

Alpine: The playground needs a great deal of attention. The vegetation is overgrown, trees need to be cut back, sand needs to be removed and new sand added. Most importantly, all of the equipment needs to be power-washed. Add wood fiber after the power washing is complete.

Hannah Williams: The playground is in constant use [by residents and non-residents] and therefore I recommend high frequency inspections on a regular schedule. Wood fiber needs to be raked to fill gullies, and this should be checked on a consistent basis. Secondly, the playground seems to be the place where people bring their unwanted residential play toys and equipment. I would recommend you consider discouraging this by perhaps posting a sign; and have your staff remove the equipment that is left every so often. Remove all sand and add new sand. An information sign is needed to provide guidance on rules and regulations.

<u>Public schools:</u> Keep the lines of communication open with the school and have proper protocol for work orders and accidents. Does the school maintain the playgrounds — or does the town?
