Dear Louise Miller:

This Notice is provided pursuant to 310 CMR 40.1400. A release of oil and/or hazardous materials (OHM) has been detected at the above-referenced location, which is considered a Disposal Site as defined by M.G.L. c. 21E, § 2 and the Massachusetts Contingency Plan (MCP), 310 CMR 40.0000 et seq, and the Massachusetts Department of Environmental Protection (MassDEP) has assigned Release Tracking Numbers (RTN) 3-34474 to the condition.

On December 28, 2020, The Town of Wayland received a petition to make the property located at 484-490 Boston Post Road (River's Edge) a Public Involvement Plan (PIP) site. On January 26, 2021, CMG Environmental Services (CMG), on behalf of the Town of Wayland, submitted an Immediate Response Action Completion & Permanent Solution Report addressing the assessment and remediation completed under RTN 3-34474. Based on the submittal of the report after the designation of the Site as a PIP site, this document is required to be available for public comment.
