Please be advised, pursuant to Town Code 36-3 (A), the original Article was amended by Petition to revise the above language to: *The Meeting will be to determine whether the Town will vote to transfer available funds from the Unclassified: Reserve for Salary Settlement FY24 and to authorize the Town Accountant to allocate said sums to and among the personnel and line items affected thereby in such amounts as are proper and required. This transfer is for the purpose of funding FY24, the first year of the collective bargaining agreements for the period of July 1, 2023 through June 30, 2024 reached between the Wayland Teachers Association (WTA), Wayland Educational Secretaries Association (WESA) and the Wayland School Committee.*
