Dear Mr. Knight:

The Massachusetts Clean Waters Act (M.G.L. c.21, s.26-53) was amended by Chapter 246 of the Acts of 1973 to authorize the Massachusetts Department of Environmental Protection ("MassDEP") to regulate discharges into all waters of the Commonwealth, including groundwaters. MassDEP regulates discharges through the issuance of discharge permits which impose limitations on the amount of pollutants which may be discharged in effluent, together with monitoring and reporting requirements and other conditions to ensure adequate treatment of all liquid wastes prior to discharge.

MassDEP has reviewed your Notice of Intent (the "NOI") application for coverage under the General Permit for Small Wastewater Treatment Facilities, submitted on January 17, 2013, on behalf of the Wayland Wastewater Management District Commission ("WWMDC"), located at 41 Cochituate Road in Wayland, Massachusetts, to discharge treated sanitary sewage from an existing on-site wastewater treatment facility (WWTF) located at 400-440 Boston Post Road to the ground at the Wayland Town Office Playing Fields located at 41 Cochituate Road. The construction of the WWTF was previously approved by MassDEP in correspondence dated August 23, 2010. Tighe & Bond, Inc., on behalf of WWMDC and the Town, provided additional information in support of the application and received MassDEP approval of a Hydrogeological Evaluation Report for the Wayland Town Office Playing Fields located at 41 Cochituate Road,

MassDEP has determined that the NOI is complete and that the proposed facility complies with the requirements for coverage under the General Permit for Small Publicly Owned Wastewater Treatment Facilities. A decision regarding this NOI cannot be finalized at this time because of provisions in the Law regulating public notice of the proposed general permit coverage and opportunity for public comments and public hearing. Following receipt of comments on the public notice, and public hearing, if necessary, the NOI will be finalized and MassDEP will issue its final determination to approve or deny the request for coverage.

Enclosed herewith is a copy of the public notice for your NOI. The enclosed public notice should be published to start the thirty (30) day public comment period.



This notice shall be published at the applicant's/permittee's expense in accordance with the requirements of 314 CMR 2.06 as amended. Please ensure that the date of printing of the notice is included by the newspaper.

In accordance with 314 CMR 2.06(3)(a) and M.G.L. c.30A, copies of this notice must also be filed with the Secretary of State for publication in the Central Register and with the Massachusetts Environmental Policy Act ("MEPA") unit for publication in the Environmental Monitor. A copy of a form letter for publication in the Central Register is enclosed for your use. Please attach a copy of the public notice to the form letter and forward this documentation in the appropriate format to the Secretary of State's Office.
